## Report from Office of Clergy and Consecrated Life

### Convocation

- The 2019 Convocation is at Boyne Mountain which is in Boyne Falls located on US 131
- The hotel facility will coordinate with the Boyne Highlands resort for details on pass needs for the AOD Convocation
- Dates for the diaconate convocation are October 17-20

### **Diaconate Assignments**

- The assignment board for the diaconate assignments will meet either Thursday or Friday April 26/27process is moving along approximately one-third of the deacons (80 +/-) are up for renewal/reassignment
- Deacons to be ordained in October 2018 have submitted their three choices of parishes
- The assignment board contains the bishops, some priests, representative from the formation team and representative from the community board
  - Stan Avery and Dennis Loffreda offered and were selected to represent the community board
- Kevin stress that the roles of the deacons on the board is really observational/advisory and the bishops ultimately have the final say on selection

#### Formation

- There are 4 new applicants and 1 re-application of a person who was accepted in 2010 but did not continue due to family issues
- The psych test are completed and the formal selection process is underway
- Seven are slated to be ordained in October
- With every information night at least one potential candidate has begun classes
  - Next information evening is April 25 at St Thomas the Apostle parish

#### **Central Offices**

- As a fyi to the new board members, it was noted that Erin Russell is only ½ time with the diaconate department with the balance of her employment time spent with the immigration department
- Immigration duties include
- Making sure the foreign priest have all the proper and current documentation
- Dealing with foreign students mainly high school to bringing them in to a local diocesan school with the proper documentation and following regulations

## USCCB visit wrap up

- The formal report is in the hands of Fr Spezia
- Kevin has a formal meeting scheduled to discuss the finding received
- Kevin noted that the review was very positive with only minor suggestions to improve our diaconate program indicated
- It should be noted that although the purpose of the USCCB review was to evaluate formation, many areas of the AOD diaconate program were discussed
- It was noted that the USCCB visit was an entirely voluntary process which the AOD requested the actual request was made several years ago but due to personal changes was finally able to be accomplished
- One suggestion that came out of the report which Kevin desired to implement is a Diaconate Vocation Sub-committee to the Community Board
- The obvious purpose is to recruit more men to the diaconate in a broader and more formal fashion
- This committee would be composed of some board members and with addition "outside" deacons
- There is now a concerted effort to recruit more minorities into the diaconate programs with secondary spillover into the lay ministries

## Mini-Convocation

Fr Bill Promesso is the principle presenter with the topic preaching on those challenging subjects

Discussion was whether there should be a separate breakout session for the wives with the ladies in attendance expressing an interest to listen to Fr Promesso

A discussion followed about homilies and homiletic training with a realization that even after years we are still learning.

The comment was made that homiletic training in the seminary was inadequate

Wives have been instrumental in helping the deacon prepare their homilies and therefore feel that sitting in on the mini-convocation session would be beneficial to their husbands

## Newly Ordained Deacon Event

- Decision is to have a breakfast on Saturday April 21, 2018 from 9am to 11 am at SHMS
- Those ordained on October of 2016 and October 2017will be invited
- The main goal is to find out how they are doing with secondary goals fellowship and creating interest in providing service to and being involved with the community at large
- The newly ordained guests will be sent a series of reflective question to help with our discussion
- Glenn prepared a questionnaire based on discussion from the prior board meeting and shared it with the Board for comment and review
- The questionnaire will be emailed in advance of the meeting to the new deacon invitees
- Based on the discussion from the last board meeting, outgoing board members (Glenn and Sharon) invited to participate

## New Business / Open discussion

#### The annual men's retreat

- Due to conflict with the Cupuchian Retreat House as they have a "full house" for the month of June, the retreat status needs to be address
- Options include
  - o Cancelling the retreat for this year
  - o Move the retreat date to August at the same location
  - o Finding a different retreat center to host the men in mid-June
- The consensus seem to be to try for find a different location
- Dennis offered to talk to the administration at Colombiere Retreat Center in Clarkston to see
  - o If they can accommodate 15 or so deacon
  - o If they can supply a retreat director
  - o If we can share with another group and have a semi-silent retreat

Diaconal Vocation Sub-Committee - discussed earlier under Kevin's report

#### Deacon Funeral Preferences

- Bob Gajda gave a presentation on funeral form he developed for the AOD in 2014 modeled after the priest funeral intention/wish form
  - o Bob used his own personal desires as a discussion guide
  - o It was agreed that a form would be good to state wishes
- It was discussed that the deacon should have some diocesan guidelines
- Kevin will research to see if there is something through the AOD or the USCCB
- It was also suggested that the AOD Cemetery Burial Information for Deacons be distributed to all deacons so that we can know what we are entitled to and what any cost are
- A side point of discussion was that there should be available some training for deacons to help them feel comfortable planning, participating in or directing a funeral for a priest
