## AOD Diaconate Community Board Meeting Minutes 06 16 16

Meeting Called to Order - 8:00 am

Minutes of April 18, 2016 - approved

Election/Lottery for term extension for 3 board members to 3 years – Tim and Martha Maxwell, Dennis and Brigid Loffreda, Glenn and Sharon Melenyk

Report from Office of Clergy and Consecrated Life

- Diaconate assignment changes will be announced after July 1
  - o Will be published in the clergy mail
  - o For those without email the clergy mail will be send via regular mail
  - Anyone not receiving regular communications should notify Kevin or Pia at the office
  - Approximately 10 assignment changes will be listed
  - Potential assignments have also been discussed for the four to be ordained in October
- Pia has been busy with immigration duties
- The men's retreat has 15 registrants so far
  - Msgr Tim Hogan is the retreat director
- The 2017 Convocation at Boyne Highlands is scheduled for September 28 through October 1
- The 2017 Permanent Diaconate Ordination is scheduled for Saturday October 14 note the change from the first Saturday in October due to the convocation
- The new formation class is expected to have 5 aspirants one of which is conditional dependent upon pre-requisite class completion
  - o There were 10 applicants with 5 denials and 1 withdrawal
  - Those who attend the information night are quick to start classes as soon as possible
- The USCCB formation review is expected to take place in the Spring of 2017
  - There is some preliminary work to be done
  - o Kevin gave the board a series of questions to answer
  - o The request is to have the responses returned to Kevin within 40 days
  - The review team is expected to consist of six people from the USCCB and Diaconate Directorate
- Suggestion made and discussion ensued about moving the Diaconate Assignments to October from the current July time frame
  - This would allow a transition time for priest assignments, especially pastors, to assess needs and allow the deacons time to see if the new pastor needs a deacon who meets their needs

- Note that deacons who have chosen senior retired status still have full faculties and can serve in a parish as a deacon
- Suggestion was made to publish the deacons to be ordained in the Michigan Catholic prior to ordination similar to the priests as a "public notice" similar to wedding bands

### **Old Business**

- Convocation is still in need of speakers suggestions gladly accepted
  - o As of now diaconate is responsible to get own speakers
  - Priest convocation is in the planning stages maybe able to get some ideas from them
- As of the meeting Peter and Kathy Hebeck were scheduled for the couples retreat however since the meeting they have needed to cancel – still looking
- Steve Mitchell is schedule speaker for the fall Mini-Convocation Saturday October 29, 2016
- Kevin asked to develop a committee to plan event for the 50th anniversary of the restoration of the permanent diaconate
- Discussions for day of reflection at the Fr Solanus Casey Center thought was to have a Saturday event with a tour and lunch at the center during Advent
  - o Kevin will contact Roseanne Jamieson for more information and possible date
  - Updated January 7 would work which includes lunch and a tour there is a \$50 fee for the person to prepare the lunch (covered by the diocese) and a \$10 person soup and sandwich fee
- The plans for dedication of the memorial marker at Holy Seplecure Cemetery in the Spring of 2017 will be announced at the November Deacon memorial mass.

### **New Business**

- Legal issues arising because of our duties as deacons
  - o Tim Maxwell was subpoenaed on a child custody case to appear in court
  - He was involved in help with the annulment of one of the parties
  - He called the diocese trying several departments including tribunal and chancellors office
  - o Legal counsel was assigned by the diocese
  - Perhaps something should be added to the diaconate Manuel and/or placed in community news about how and who to contact
- Dave Carignan was concerned about background checks which ask for social security numbers in order to distribute Holy Communion to nursing homes
  - There are a number of facilities that require checks, while many do not security is becoming more and more prominent - at this point each place seems to be setting their own rules
  - Many facilities will forgo requirement of the social security number when reasonable alternate identifying information is given
- The diaconate handbook is scheduled to be released in September
- Dennis share with us his experience at the Jubilee of Deacon in Rome including the stole he wore at the Mass Thank you for sharing
